DISASTER RECOVERY TRIPLE P

WHAT IS DISASTER RECOVERY TRIPLE P?

A parenting information presentation delivered to a large group of parents (20 to 200) having experienced a natural disaster. The seminar aims to help parents understand children's social and emotional reactions to disasters, how to support children's resilience and encourage them to naturally resolve their distress, and answer their children's questions about what happened and what might happen in the future. The seminar takes around 90 minutes to present, plus 30 minutes for question time.

WHO IS IT FOR?

Parents or caregivers, with children up to 12 years or teens, who have experienced a natural disaster. Disaster Recovery Triple P is designed as an informational support not as a treatment for excessive trauma reactions although some people may benefit from attending these seminars as an avenue for accessing further help.

WHAT IS COVERED IN SESSIONS WITH PARENTS?

During the seminar parents are introduced to the following:

- Common social and emotional reactions of children following a disaster.
- The natural course of children's responses.
- Why some children are more affected than others.
- Parent traps.
- Managing children's emotions following the disaster.
- Answering children's questions.

HOW MUCH TIME IS NEEDED TO DELIVER THE INTERVENTION?

In addition to each seminar, the practitioner should allow time for preparing for the seminar and supervision. Please see the table below for an approximate delivery guideline time for each seminar.

WHAT IS INVOLVED IN PROVIDER TRAINING?

To provide Disaster Recovery Triple P to families, practitioners must have completed an approved active skills training programme and demonstrated their knowledge and competence in programme delivery through a skills-based accreditation process.
